- 5. That school is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organisation or body.
- 6. That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
- 7. That the Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the Bond from time to tie. The chool undertakes to abide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law of the land.
- That the school will ensure compliance of all statutory requirements like EPF/ESI and Labour Laws etc. with respect to the school and staff of the school.
